**ENTIRE AGREEMENT:** This agreement contains the entire understanding between Emily Lim Fine Art Photography and the CLIENT. It supersedes all prior and simultaneous agreements between the parties.

**RESERVATION:** A signed contract and reservation fee are required to reserve the specified coverage.

**PRE-EVENT CONSULTATION:** The parties agree to a pre-event consultation before the event date in order to finalize the actual shooting times, locations, and CLIENT'S request list (in writing) for specific photographs. The bride and or groom agree to set aside at least one hour of time for the photographs, preferably 1 and a half hours.

**SHOOTING TIME / ADDITIONS:** The photography schedule and selected methodology are designed to accomplish the goals and wishes of the CLIENT in a manner enjoyed by all parties. CLIENT and Emily Lim Fine Art Photography agree that cheerful cooperation and punctuality are therefore essential to that purpose. Shooting commences at the scheduled start time. Any hours extending beyond the agreed end time are \$100 extra per half hour.

**HOUSE RULES:** The photographer is limited by the guidelines of the ceremony official or reception site management. CLIENT agrees to accept the technical results of their imposition on the photographer.

**MODEL RELEASE.** The CLIENT hereby grants to Emily Lim Fine Art Photography and its legal representatives and assigns, the irrevocable and unrestricted right to use and publish photographs of the CLIENT or in which the CLIENT may be included, for editorial, trade, advertising and any other purpose and in any manner and medium; to alter the same without restriction; and to copyright the same. The CLIENT hereby releases Emily Lim Fine Art Photography and its legal representatives and assigns from all claims and liability relating to said photographs.

**LIMIT OF LIABILITY:** In the unlikely event that the photographer is injured or becomes too ill to photograph the event, Emily Lim will make every effort to secure a replacement photographer. If the situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the event package. Emily Lim Fine Art Photography takes the utmost care with respect to exposure, transportation, and processing the photographs. However, in the unlikely event that photographs have been lost, stolen, or destroyed for reasons within or beyond Emily Lim Fine Art Photography's control, Emily Lim Fine Art Photography liability is limited to the return of all payments received for the event package. The limit of liability for a partial loss of originals shall be a prorated amount of the exposures lost based on the percentage of total number of originals.

**SECURITY DEPOSITS:** In the event of cancellation, \$200 of your deposit paid is non-refundable but the remainder shall be returned. The CLIENT shall also be responsible for payment for any Emily Lim Fine Art Photography materials charges incurred up to time of cancellation.

**COMPLETION SCHEDULE:** Film developing and CD creation takes between two weeks to one month.

**PAYMENT SCHEDULE:** 50% due at time of signing of agreement. Balance payable in full at time of wedding.
